Receipt of online payment must be furnished. The amount be deposited in full. In case of needy candidates (written application is required) tuition fee & training expenses may be collected in 04 equal installments subject to approval of the competent authority.

- iii) Original Domicile Certificate.
- iv) **Attested copies of academic Certificates/DMCs from respective Board.**
- v) Three passport size photographs.
- vi) **Migration certificate from the board last attended.**
- vii) Undertaking on stamp paper of Rs. 100/- as per specimen, available at PFI web site.
- viii) Father's valid employment certificate for reserved seat candidates only.
- ix) Medical Fitness Certificate Issued by Senior Medical officer, PFI Hospital.
