No SO(Estt)FE&WD/V-20/2019:- In pursuance of the provisions contained in sub-rule (2) of rule 3 of the Khyber Pakhtunkhwa Civil Servants (Appointment, Promotion and Transfer) Rules 1989, the Forestry, Environment and Wildlife Department, in consultation with the Establishment Department and the Finance Department, hereby, directs that in this Department Notification No. SO(ESTT)/FE&WD/V-20/2019/3891-2304, dated 16th April, 2019, the following further amendment shall be made namely:

AMENDMENTS

In the APPENDIX:-

- (a) against Serial No. 1, in Column No. 5, for the existing entry, the following shall be substituted, namely:

5
"By transfer of officers from PAS/PMS.";

- (b) against Serial No. 77, in Columns No. 3, 4 and 5, for the existing entries, the following shall respectively be substituted, namely:

"At least Second Class Bachelor's Degree or its equivalent Qualification from a recognised University.	20 to 32 Years.	(i) Seventy-five percent by promotion, on the basis of seniority-cum-fitness, from amongst the holders of the posts of Senior Clerk (BPS-14), with seven years service as Junior Clerk (BPS-11) and Senior Clerk (BPS-14) and Accountants (BPS-14), with seven years as such; and (ii) Twenty-five percent by initial recruitment. Note: A joint seniority list of Senior Clerks (BPS-14) and Accountants (BPS-14) shall be maintained for the purpose of promotion.";

- (c) against Serial No. 78, in Column No. 5, for the existing entry, the following shall be substituted, namely:

"By promotion, on the basis of seniority-cum-fitness, from amongst the holders of the posts of Steno Typists (BPS-14), with five years service as such.";

- (d) against Serial No. 85, in Columns No. 4 and 5, for the existing entries, the following shall respectively be substituted, namely:

"18 to 32 Years.	(i) Fifty percent by promotion, on the basis of seniority-cum-fitness, from among the holders of posts of Motor Mechanics (BPS-07) and Mechanics (BPS-07), with seven years service as such; and (ii) Fifty percent by initial recruitment. Note: A joint seniority list of Motor Mechanics (BPS-07) and Mechanics (BPS-07) shall be maintained for the purpose of promotion.";

- (e) against Serial No. 87, in Column No. 5, for the existing entry, the following shall be substituted, namely:

"By promotion, on the basis of seniority-cum-fitness, from amongst the holder of the posts of Herbarium Keeper (BPS-07), with seven years service as such.";

- (f) against Serial No. 91, in Columns No. 4 and 5, for the existing entries, the following shall respectively be substituted, namely:

"18 to 32 Years.	(i) Fifty percent by promotion, on the basis of seniority-cum-fitness, from amongst the holders of the posts of Lab Assistants (BPS-08), with seven years service as such; and (ii) fifty percent by initial recruitment.";

- (g) against Serial No. 109 in Columns No. 4 and 5, for the existing entries, the following shall respectively be substituted, namely:

"—	By promotion, on the basis of seniority-cum-fitness, from amongst the holders of the posts of Head Malis (BPS-04), with fifteen years service as such.";

- (h) against Serial No. 110 in Columns No. 4 and 5, for the existing entries, the following shall respectively be substituted, namely:

"18 to 32 Years.	(i) Fifty percent by promotion, on the basis of seniority-cum-fitness, from amongst the holders of the posts of Tennis Markers (BPS-05), with five years service as such; and (ii) fifty percent by initial recruitment.";

- (i) against Serial No. 116 in Columns No. 3, 4 and 5, for the existing entries, the following shall respectively be substituted, namely:

At least Second Division Intermediate (Pre-Medical) in Science or its equivalent qualification from a recognized Board.	"18 to 32" Years.	(i) Fifty percent by promotion, on the basis of seniority-cum-fitness, from amongst the holders of the posts of Museum Attendants (BPS-03), with five years service as such; (ii) Fifty percent by initial recruitment.";

- (j) against Serial No. 117 in Columns No. 3 and 4, for the existing entries, the following shall respectively be substituted, namely:

"At least Second Division Secondary School Certificate or its equivalent qualification from a recognized Board with one year experience in wood lacker and natural/ spirit polishing.	18 to 32 years.

- (k) against Serial No. 118 in Columns No. 3 and 4, for the existing entries, the following shall respectively be substituted, namely:

"At least Second Division Secondary School Certificate or its equivalent qualification from a recognized Board with one year experience in wood sawing and basic knowledge of saw mill.	18 to 32 years.

- (l) against Serial No. 121, in Columns No. 4 to 5, for the existing entries, the following shall respectively be substituted, namely:

"18 to 32 years.	(i) Twenty-five percent by promotion, on the basis of seniority-cum-fitness, from amongst the holders of the posts of Cleaners (BPS-03), having ten years service as Cleaners with LTV/ HTV License; and (ii) seventy five percent by initial recruitment.";

- (m) against Serial No. 132, in Columns No. 3, for the existing entry, the following shall be substituted, namely:

"Retired from Armed Forces, Para-Military Forces and Police, with Secondary School Certificate from a recognized Board,".
