### NOTIFICATION

**No. SO(ESTT)FE&WDIV-20/2k19:** In pursuance of the provisions contained in sub-rule (2) of rule of the Khyber Pakhtunkhwa Civil Servants (Appointment, Promotion and Transfer) Rules, 1989, the Forestry, Environment & Wildlife Department, in consultation with the Establishment Department and the Finance Department, hereby direct that in this department Notification No.SO(ESTT)FE&WDIV-20/2019/3891-3904, dated 16/4/2019, the following further amendments shall be made, namely:

### AMENDMENTS

In the APPENDIX, against Serial No.93, in Column No. 3 and 5, for the existing entries, the following shall be substituted, namely:-

i. F.A/F.Sc with second Division or equivalent from a recognized board; and	18 to 30 Years	i. Forty percent by promotion, on the basis of seniority-cum-fitness, from amongst the Daftaries (BS-4), Naib Qasids (BS-3), Khalasi (BS-3), including holders of other equivalent posts with two years services as such, who have passed F.A/F.Sc Examination or its equivalent qualification from a recognized board; and ii. Sixty percent by initial recruitment.
ii. Speed of words per minute in typing, thirty (30)		<b>Note:—</b> For the purpose of promotion, there shall be maintained a combined seniority list of the Daftaries (BS-4), Naib Qasids (BS-3), Khalasi (BS-3), including holders of other equivalents posts with reference to the dates of their acquiring the F.A/F.Sc qualification. Provide that:- a) If two or more officials have acquired the F.A/F.Sc qualification in the same session, the inter-so seniority in the lower post shall be maintained for the purpose of determining seniority in the higher post; and b) Where a senior official does not possess the requisite qualification at the time of filling up a vacancy, the official next junior to him possessing the requisite to the senior officers or officials.

		<p>Provided further that the condition of FAF.Sc or its equivalent qualification from a recognized Board, as laid down at clause (j) shall not apply till the expiration of period as specified in second proviso of Column No.5 against S.No.4 of the Establishment Department's amendment Notification No. SOE.IV(E&amp;A) 1-35/2014, dated 18.7.2019, to the existing inarticulate incumbents of the post of Callaries (BS-4), Nash Qasids (BS-3), Khatals (BS-3), including holders of other equivalent posts for promotion to the post of Junior Clerk (BS-11).</p>
